What is intended?

India simultaneously faces undernourishment, rising overweight-obesity, and micronutrient deficiencies. Capacity in India to address the burden of these multiple forms of malnutrition is limited. Addressing these inter-related challenges throughout the life-course requires a holistic, coordinated, multi-sectoral approach to effectively and sustainably improve nutrition outcomes.

Through this 4 day course, participants will be guided through cutting-edge knowledge and evidence on nutrition nationally and globally. The course will equip participants to:

- (1) develop skills in reading and interpreting the relevant literature, understand the data and evidence necessary for relevant situational diagnostics
- (2) identify strategies for nutrition action, evaluating potential interventions, and developing appropriate policies that might be useful in their context.

Who should attend?

Professionals engaged in policy making or working with nutrition and health oriented national programs in government departments, think tanks, NGOs, bi-/multi-lateral organizations; Faculty members engaged as program practitioners, consultants, technical officers in fields of nutrition, public health and life sciences. A minimum of 2 years' work experience is desirable.
